This management discussion and analysis (“MD&A”) focuses on significant factors that affected ValOre during the year ended September 30, 2018, and to the date of this report. The MD&A supplements but does not form part of the audited annual financial statements of ValOre and the notes thereto for the years ended September 30, 2018 and 2017. Consequently, the following discussion and analysis should be read in conjunction with the audited annual financial statements and the notes thereto for the years ended September 30, 2018 and 2017.

INTRODUCTION

ValOre Metals Corp. ("ValOre" or the "Company") formerly named Kivalliq Energy Corporation, is an exploration company based in Vancouver, Canada, currently holding exploration projects in Northern Canada. In addition to uranium exploration properties in Nunavut Territory and the Provinces of Saskatchewan and Manitoba, the Company also has the Baffin Gold Property in Nunavut Territory.

HIGHLIGHTS

- On October 10, 2017, the Company announced the completion of a 1,943 line-kilometre helicopter-borne electromagnetic survey at the Hatchet Lake Property and Genesis Property uranium projects.
- On October 25, 2017, the Company announced results from the 2017 summer exploration program at ValOre's 100% owned, Baffin Gold Property.
- On March 27, 2018, the Company announced it had received a CDN\$600,000 payment from Sandstorm Gold Ltd. in return for a 1.75% net smelter returns royalty on the Baffin Gold Property, in addition, the Company announced it had exercised an Option to acquire 100% of Commander Resources Ltd.'s portion of the Baffin Gold Property.
- On June 13, 2018 the Company announced a proposed consolidation of the common shares of the Company on the basis of ten (10) pre-consolidation shares for one (1) post consolidation share. In conjunction with the consolidation, the Company's name was changed to ValOre Metals Corp from Kivalliq Energy Corporation.
- On June 26, 2018 the company announced that on June 28, 2018, the Company's name will be officially changed to ValOre Metals Corp. ("ValOre") and that ValOre's shares will trade on the Toronto Venture Exchange under the ticker symbol ("VO") on the basis of ten (10) pre-consolidation shares for one (1) post consolidation share.
- On August 16, 2018 ValOre announced the completion of the 2018 summer exploration program at ValOre's 100% owned Baffin Gold Property in Nunavut Territory. The 2018 program included a 7,038 line-kilometre aeromagnetic survey and the collection of 431 till and 31 rock geochemical samples. With this new survey, the company now has continuous airborne geophysical data covering 120 kilometres of the prospective Foxe Fold Belt. All samples will be sent to ALS Geochemistry (ALS) in Vancouver, BC for analysis.
- Subsequent to the reporting period, on December 14, 2018 ValOre announced results from the 2018 summer exploration program at the Baffin Gold Property. Results from 438 till geochemical samples outlined three, kilometre-scale areas with anomalous gold in underexplored, prospective geology west

of the high-grade Brent and Ridge occurrences. Results from 31 rock samples confirmed high-grade gold at Durette, A 6,984 line kilometres airborne horizontal gradient magnetic survey now provides near-continuous geophysical coverage across 110 kilometres of strike on the Property.

MINERAL PROPERTIES AND EXPLORATION

Angilak Property, Nunavut

ValOre's 100% owned Angilak Property comprises a total area of 60,363 hectares, consisting of a central Inuit Owned Land parcel RI-30 57 mineral claims and one mineral lease on Federal Crown lands. The property is subject to a 1% net smelter return ("NSR") royalty and is located approximately 225 kilometres southwest of the community of Baker Lake in the ValOre region of southern Nunavut Territory.

Since acquiring the Angilak Property in 2008, the Company has invested approximately \$55 million conducting systematic exploration, including: ground and airborne geophysics, geological mapping; prospecting, and over 90,500 metres of diamond and reverse circulation ("RC") drilling.

The Angilak Property hosts the "Lac 50 Trend" uranium deposit, with a NI 43-101 Inferred Resource of 2,831,000 tonnes grading 0.69% U₃O₈, totaling 43.3 million pounds U₃O₈. ValOre's comprehensive exploration programs, and new discoveries, continue to demonstrate the "District Scale" potential of the Angilak Property. For disclosure related to the inferred resource for the Lac 50 Trend uranium deposits, please refer to ValOre's news release of March 1, 2013.

ValOre's 2015 program led to the new Dipole discovery located within the Dipole-RIB Trend. Drilling returned multiple intervals of significant near surface uranium mineralization. The Dipole-RIB Trend is located approximately 25 km southwest of Lac 50 deposit and drill results demonstrate that Lac 50-type mineralization exists in multiple trends on the Angilak Property.

On November 8, 2016, the Company announced the results from its 2016 summer exploration program at the Yat and Dipole Target areas. The results confirmed that the high-grade polymetallic U-Cu-Ag-Au (Pt-Pd) mineralization identified in boulders at Yat- is derived from localized bedrock sources.

Baffin Gold Property, Nunavut

On May 8, 2017 the Company announced a strategic addition to its project portfolio through the acquisition of a dominant land position over one of the largest undeveloped greenstone-iron formation gold belts in Nunavut, Canada. The Baffin Gold Property totals 405,083 hectares and covers 160 kilometres of the Foxe Fold Belt on central Baffin Island.

The Baffin Gold Property is a district-scale land package comprised of consolidated mineral tenure, located approximately 230 kilometers southwest of the community of Clyde River on Baffin Island, in the Qikiqtani region of Nunavut. By entering a Mineral Exploration Agreement ("MEA") directly with Nunavut Tunngavik Inc. ("NTI") on Inuit Owned Lands, acquiring 15 prospecting permits from Indigenous Northern Affairs Canada and further acquiring an Option to earn 100% on two additional MEA's with NTI and 6 crown mineral claims held by Commander Resources Ltd., ValOre has established a dominant land position and exclusive control over one of the largest undeveloped greenstone-iron formations in Canada. The Baffin Gold Property covers an entire Proterozoic gold belt having geological and structural similarities to multi-million-ounce gold mines in the north (i.e. Meadowbank, Lupin) as well as the prolific Homestake Mine in South Dakota. Previous exploration has identified numerous prospects along 140 kilometers of strike length, with high-grade gold occurring in multiple settings: silicate and sulphide iron formation; shear zones and quartz veins hosted in granodiorite, metavolcanics and metasediments. BHP-Billiton, Falconbridge, Commander Resources and AngloGold Ashanti have conducted exploration programs on the Property with extensive geoscience databases worth over \$25 million. The Property also has an existing camp, tidewater access and two 1,200m airstrips, which will accelerate future work programs and potentials.

On July 25, 2017, the Company announced a \$775,000 summer exploration program. The program focused on multiple geological and structural settings hosting significant gold mineralization primarily on Inuit Owned Land parcels, and more specifically, the Kanosak and Central Belt areas.

On October 25, 2017, the Company announced results from the 2017 summer exploration program. Rock sample results confirmed high-grade gold in banded iron-formation and metasediment hosted quartz veins. Geochemical sample results identified a new 10km long corridor of anomalous gold at south Kanosak. Rock and new till geochemical results have also extended the strike length of known gold occurrences at Brent, confirmed gold in banded iron formation at west and north Kanosak and expanded anomalies around historic gold in till results.

On March 27, 2018, the Company announced it had received a CDN\$600,000 payment from Sandstorm Gold Ltd. in return for a 1.75% net smelter returns royalty on the Baffin Gold Property, in addition, the Company announced it had exercised an Option to acquire 100% of Commander Resources Ltd.'s portion of the Baffin Gold Property.

On August 16, 2018 the Company announced completion of the 2018 summer exploration program. The 2018 program included a 7,038 line-kilometre aeromagnetic survey and the collection of 431 till and 31 rock geochemical samples.

On December 14, 2018, ValOre announced results from the 2018 summer exploration program at the 100% owned Baffin Gold Property. Results from 438 till geochemical samples infilled work from 2017 work and outlined three, kilometre-scale areas with anomalous gold in underexplored, prospective geology west of the high-grade Brent and Ridge occurrences. Results from 31 rock samples confirmed high-grade gold at Durette. A 6,984 line kilometres airborne horizontal gradient magnetic survey was flown on two grids providing the company with near-continuous geophysical coverage across 110 kilometres of strike on the Property.

Baker Basin, Nunavut

The Baker Basin Property is located south of the hamlet of Baker Lake, Nunavut Territory, Canada. ValOre acquired 100% of Pacific Ridge Exploration Ltd's ("PEX") ownership interest in the Baker Basin Uranium Property through payment of 60,000 of ValOre, \$55,000 in cash and a \$70,000 private placement purchase of PEX units.

During the year ended September 30, 2018 the Company determined it will not conduct further exploration on the Baker Basin property and therefore wrote the property down to a value of \$Nil.

Genesis Property, Saskatchewan & Manitoba

ValOre's jointly owned (50% ValOre) Genesis Property begins 25 kilometres northeast of Cameco Corporation's Eagle Point uranium mine site and extends 90 kilometres to the northeast along this favourable geological and structural domain to the Manitoba border. In March 2018, the Property was reduced to 18 mineral claims totaling 36,949 hectares.

On October 4, 2016, the Company announced the completion of a field program on the Genesis Property. A total of 187 enzyme leach soil samples, 147 biogeochemical samples and two rock samples were collected along the Jurgen 1 and Jurgen 2 target area trends. Sampling focused on infilling enzyme leach soil samples at Jurgen 1 and expansion of the enzyme leach and biogeochemical grids to cover newly identified gravity low anomalies along the trend to the northeast.

On September 1, 2017 Roughrider Exploration Limited ("Roughrider") earned a 50% Initial Interest in the Genesis Property by completing expenditure commitment obligations to ValOre pursuant to the terms of the Option Agreement with ValOre. Roughrider has the right to acquire up to an 85% interest in the Property.

On October 10, 2017, the Company announced the completion of a 1,943 line-kilometre helicopter-borne electromagnetic survey at the Hatchet Lake Property and Genesis Property uranium projects. Geotech Ltd. of Aurora, Ontario was contracted to fly the survey using their ZTEM™ system, with in3D Geoscience Inc. providing independent QA/QC during data acquisition. The Genesis Property ZTEM™ survey was divided into four separate grids providing additional geophysical coverage over the Jurgen, Kingston, Johnston/GAP and Daniels Bay priority target areas.

Hatchet Lake Property, Saskatchewan

ValOre's 100% owned Hatchet Lake Property consists of 6 claims totaling 13,711 hectares, located adjacent to the north-eastern margin of the Athabasca Basin in Saskatchewan and 3.5 kilometres north west of ValOre's Genesis Property. Also located 39 kilometres along trend from the Roughrider uranium deposit and within 29 kilometres of Cameco's Eagle Point uranium mine site, the Hatchet Lake Property is subject to a 2% Net Smelter Return ("NSR") royalty granted to Rio Tinto. With ValOre holding a buy-down right of 0.5% for \$750,000.

In January 2017, ValOre transferred and assigned the Company's 0.5% buyback in the NSR to Sandstorm Gold Ltd. ("Sandstorm"), and if exercised, ValOre has agreed to grant a 0.5% NSR royalty payable on all mineral products produced from the Hatchet Lake property.

On October 10, 2017, the Company announced the completion of a 1,943 line-kilometre helicopter-borne electromagnetic survey at the Hatchet Lake Property and Genesis Property uranium projects. Geotech Ltd. of Aurora, Ontario was contracted to fly the survey using their ZTEM™ system, with in3D Geoscience Inc. providing independent QA/QC during data acquisition. The Hatchet Property survey totalled 720-line kilometres. The ZTEM™ survey will enhance earlier airborne geophysical data in areas having priority geochemical anomalies.

FINANCING & CORPORATE DEVELOPMENTS

ValOre expects to obtain financing in the future primarily through further equity and/or debt financing, as well as through joint venturing and/or optioning ValOre's properties to qualified mineral exploration companies. There can be no assurance that ValOre will succeed in obtaining additional financing, now or in the future. Failure to raise additional financing on a timely basis could cause ValOre to suspend its exploration activities and eventually to forfeit or sell its interest in its mineral properties.

On March 27, 2018 the Company announced that it had received a CDN\$600,000 payment from Sandstorm Gold Ltd. ("Sandstorm") in return for ValOre granting to Sandstorm up to a 1.75% net smelter returns ("NSR") royalty payable on all future mineral production from ValOre's Baffin Gold Property, located in Nunavut Territory, Canada. At any time up and until 36 months after signing the agreement, ValOre may reduce the Royalty to a 1.0% NSR by making a CAD\$1.0 million payment to Sandstorm. The net proceeds received from Sandstorm will be used to fund exploration and property costs at ValOre's projects in Canada, as well as for general corporate purposes.

On March 27, 2018 the Company also announced that it has exercised the Option to earn a 100% project interest on portion of the Baffin Gold Property from Commander Resources Ltd., as described in a news release on May 8, 2017, by issuing 25,000 ValOre shares to Commander.

On June 13, 2018 the Company announced a proposed consolidation of the common shares of the Company on the basis of ten (10) pre-consolidation shares for one (1) post consolidation share. In conjunction with the consolidation, the Company's name will be changed to ValOre Metals Corp.

On June 26, 2018 the Company announced that on June 28, 2018, the Company's name will be officially changed to ValOre Metals Corp. ("ValOre") and that ValOre's shares will trade on the Toronto Venture

Exchange under the ticker symbol (“VO”) on the basis of ten (10) pre-consolidation shares for one (1) post consolidation share.

On January 15, 2019 the Company completed a rights offering which expired on January 8, 2019, raising a total of \$2,450,000.

In connection with the rights offering, the Company issued a total of 24,500,000 common shares of the Company under the offering at a price of \$0.10 per common share and issued an aggregate of 2,450,000 bonus warrants. Each bonus warrant is exercisable into a common share at a price of \$0.23 per common share for two years from the date of issuance.

The company paid a solicitation fee of \$9,598 and issued 95,985 warrants in connection with the distribution of securities in the rights offering. The warrants issued as part of the solicitation fee are exercisable for one common share at a price of \$0.23 and valid for two years from closing.

RESULTS OF OPERATIONS

As at September 30, 2018 exploration and evaluation assets totalled \$57,702,577 (September 30, 2017 - \$57,307,808) and details of the cost break-down are contained in the Schedule of Exploration and Evaluation Assets in the financial statements.

ValOre’s loss from operations for the year ended September 30, 2018 was \$1,377,461 or (\$0.06) per common share (2017 – \$515,430 or (\$0.02) per common share). Assets totalled \$58,314,742 as at September 30, 2018 (September 30, 2017 - \$59,340,175).

For the Year Ended September 30, 2018

Net loss before income taxes for the year ended September 30, 2018 was \$1,658,233 or (\$0.07) per common share (2017 - \$679,272 or (\$0.03) per common share). The major areas of expenditure during the period were:

- Listing and filing fees decreased from \$21,995 in 2017 to \$15,709 in 2018 due to lower filing fees.
- Salaries and consulting fees increased from \$247,984 in 2017 to \$561,305 in 2018 due to the adjustments in compensation to the CEO, CFO and payment of directors' fees.
- Travel and conference expenses decreased from \$54,062 in 2017 to \$16,176 in 2018 due to reduced travel costs.
- Transfer agent fees increased from \$9,624 in 2017 to \$18,443 in 2018 due to share consolidation and name change costs.

For the Three Month Period Ended September 30, 2018

Net loss before income taxes for the three-month period ended September 30, 2018 was \$822,788 or (\$0.046) per common share (2017 - \$320,513 or (\$0.01) per common share). The major areas of expenditure during the period were:

- Listing and filing fees decreased from \$4,177 in 2017 to \$1,176 in 2018 due to lower filing fees in the period.
- Salaries and consulting fees increased from \$112,626 in 2017 to \$153,424 in 2018 due to higher consulting fees.
- Travel and conference expenses decreased from \$13,848 in 2017 to \$3,722 in 2018 due to reduced travel costs.
- Transfer agent fees increased from \$5,305 in 2017 to \$10,544 in 2018 due to share consolidation and name change costs.

LIQUIDITY AND CAPITAL RESOURCES

ValOre is in the exploration stage and therefore has no regular cash flow. At September 30, 2018, ValOre had working capital of (\$99,628) (September 30, 2017 - \$1,554,068).

Cash and cash equivalents totalled \$145,557 as at September 30, 2018 (September 30, 2017 - \$1,097,072).

During the year ended September 30, 2018, ValOre spent a total of \$1,134,032 (2017 – \$1,538,366) on the Company’s exploration and evaluation expenditures, spent \$417,483 (2017 - \$720,865) on operating activities, received \$nil (2017 – \$72,144) from the sale of marketable securities, and received \$nil (2017 – \$1,938,440) from the issuance of shares from a private placement.

At September 30, 2018, ValOre’s investment in exploration and evaluation assets, aggregated \$57,702,577 (September 30, 2017 - \$57,307,808), made up of the following:

At September 30, 2018, share capital totalled \$61,748,478 was comprised of 24,724,677 issued and outstanding common shares (September 30, 2017 - \$61,730,998 comprised of 24,699,673 issued and outstanding common shares). As a result of the loss for the year ended September 30, 2018 of \$1,377,461 (year ended September 30, 2017 - \$515,430), the deficit at September 30, 2018 was \$18,551,958 (September 30, 2017 - \$17,174,497). With contributed surplus of \$11,608,187 (September 30, 2017 - \$11,102,447), the shareholders’ equity at September 30, 2018 was \$54,607,617 (September 30, 2017 - \$55,635,709).

ValOre plans to utilize the expertise of its board and management to raise additional funds to undertake its planned exploration activities and to meet its administrative overhead expenses for at least the next twelve months. Actual funding requirements may vary from those planned due to a number of factors, including the results of exploration activity and market conditions.

ValOre expects to obtain financing in the future primarily through further equity and/or debt financing, as well as through joint venturing and/or optioning out ValOre’s properties to qualified mineral exploration companies. There can be no assurance that ValOre will succeed in obtaining additional financing, now or in the future. Failure to raise additional financing on a timely basis could cause ValOre to suspend its operations and eventually to forfeit or sell its interest in its exploration and evaluation assets.

Risks and Uncertainties

Exploration Stage Company

ValOre is engaged in the business of acquiring and exploring mineral properties with the objective of locating economic mineral deposits. The Baffin Gold Property in Nunavut and the Hatchet Lake and Genesis Properties in Saskatchewan (and Manitoba) remain at an early stage. A number of uranium-mineralized zones have been identified on the Angilak and Baker Basin properties in Nunavut. These zones are in various stages of exploration. Development of ValOre's properties will only follow upon obtaining satisfactory exploration results. There can be no assurance that ValOre's existing or future exploration programs will result in the discovery of commercially viable mineral deposits. Further, there can be no assurance that even if a mineral deposit is located, that it can be commercially mined.

Mineral Exploration and Development

The exploration and development of minerals is highly speculative in nature and involves a high degree of financial and other risks over a significant period of time which even a combination of careful evaluation, experience and knowledge may not eliminate. While discovery of a mineral deposit or ore body may result in significant rewards, few properties which are explored are ultimately developed into producing mines. Substantial expenses are required to establish ore reserves by drilling, sampling and other techniques and to design and construct mining and processing facilities. Whether a mineral deposit will be commercially viable depends on a number of factors, including the particular attributes of the deposit (i.e. size, grade, access and proximity to infrastructure), financing costs, the cyclical nature of commodity prices and government regulations (including those relating to prices, taxes, currency controls, royalties, land tenure, land use, importing and exporting of minerals, and environmental protection). The effect of these factors or a combination thereof cannot be accurately predicted but could have an adverse impact on ValOre.

Mining Operations and Insurance

Mining operations generally involve a high degree of risk. ValOre's operations are subject to all of the hazards and risks normally encountered in mineral exploration and development. Such risks include unusual and unexpected geological formations, seismic activity, rock bursts, cave-ins, and other conditions involved in the drilling and removal of material, environmental hazards, industrial accidents, periodic interruptions due to adverse weather conditions, labour disputes, and political unrest. The occurrence of any of the foregoing could result in damage to, or destruction of, mineral properties or interests, production facilities, personal injury, damage to life or property, environmental damage, delays or interruption of operations, increases in costs, monetary losses, legal liability and adverse government action. ValOre does not currently carry insurance against these risks and there is no assurance that such insurance will be available in the future, or if available, at economically feasible premiums or acceptable terms. The potential costs associated with liabilities not covered by insurance or excess insurance coverage may cause substantial delays and require significant capital outlays.

No Operating History and Financial Resources

ValOre does not have an operating history and has no operating revenues and is unlikely to generate any in the foreseeable future. It anticipates that its existing cash resources, following any proposed private placements, will be sufficient to cover its projected funding requirements for the ensuing year. If its exploration program is successful, additional funds will be required for further exploration to prove economic deposits and to bring such deposits to production. Additional funds will also be required for ValOre to acquire and explore other mineral interests. ValOre has limited financial resources and there is no assurance that sufficient additional funding will be available to it fulfill its obligations or for further exploration and development, on acceptable terms or at all. Failure to obtain additional funding on a timely basis could result in delay or indefinite postponement of further exploration and development and could cause ValOre to forfeit its interests in some or all of its properties or to reduce or terminate its operations.

Government Regulation

The current or future operations of ValOre, including exploration and development activities and the commencement and continuation of commercial production, require licenses, permits or other approvals from various federal, provincial and local governmental authorities and such operations are or will be governed by laws and regulations relating to prospecting, development, mining, production, exports, taxes, labour standards, occupational health and safety, waste disposal, toxic substances, land use, water use, environmental protection, land claims of indigenous people and other matters. There can be no assurance, however, that ValOre will obtain on reasonable terms, or at all, the permits and approvals, and the renewals thereof, which it may require for the conduct of its current or future operations or that compliance with applicable laws, regulations, permits and approvals will not have an adverse effect on any mining project which ValOre may undertake. Possible future environmental and mineral tax legislation, regulations and actions could cause additional expense, capital expenditures, restrictions and delays to ValOre's planned exploration and operations, the extent of which cannot be predicted.

Failure to comply with applicable laws, regulations and permitting requirements may result in enforcement actions thereunder, including orders issued by regulatory or judicial authorities causing operations to cease or be curtailed, and may include corrective measures requiring capital expenditures, installation of additional equipment, or remedial actions. Parties engaged in mining operations may be required to compensate those suffering loss or damage by reason of the mining activities and may have civil or criminal fines or penalties imposed for violations of applicable laws or regulations.

Competition

The mineral exploration and mining business is competitive in all of its phases. ValOre will compete with numerous other companies and individuals, including competitors with greater financial, technical and other resources, in the search for and the acquisition of attractive mineral properties. ValOre's ability to acquire properties in the future will depend not only on its ability to develop its present properties, but also on its ability to select and acquire suitable prospects for mineral exploration or development. There is no assurance that ValOre will be able to compete successfully with others in acquiring such prospects.

Title to Property

ValOre has taken precautions to ensure that legal titles to its property interests are properly recorded. There can be no assurance that ValOre will be able to secure the grant or the renewal of exploration permits or other tenures on terms satisfactory to it, or that governments in the jurisdictions in which the properties are situated will not revoke or significantly alter such permits or other tenures or that such permits and tenures will not be challenged or impugned. Third parties may have valid claims underlying portions of ValOre's interests and the permits or tenures may be subject to prior unregistered agreements or transfers or native land claims and title may be affected by undetected defects. If a title defect exists, it is possible that ValOre may lose all or part of its interest in the properties to which such defects relate.

Permitting and Regulatory Risks

Amendments to current laws, regulations and permits governing operations and activities of mining companies could have a material adverse impact on the Company. As well, policy changes and political pressures within and on federal, territorial, and First Nation governments having jurisdiction over or dealings with the Company could change the implementation and interpretation of such laws, regulations and permits, also having a material adverse impact on the Company. Such impacts could result in one or more increases in capital expenditures or reduction or delays in further exploration activities.

Environmental Risks and Hazards

All phases of ValOre's operations will be subject to environmental regulation in the jurisdictions in which it intends to operate. These regulations mandate, among other things, the maintenance of air and water quality standards and land reclamation, and provide for restrictions and prohibitions on spills, releases or

emissions of various substances produced in association with certain mining industry activities and operations. They also set forth limitations on the generation, transportation, storage and disposal of hazardous waste. A breach of such regulation may result in the imposition of fines and penalties. In addition, certain types of mining operations require the submission and approval of environmental impact assessments. Environmental legislation is evolving in a manner which will require stricter standards and enforcement, increased fines and penalties for non-compliance, more stringent environmental assessments of proposed projects and a heightened degree of responsibility for companies and their officers, directors and employees. The cost of compliance with changes in governmental regulations has the potential to reduce the viability or profitability of operations. Environmental hazards may exist on the properties in which ValOre holds interests or on properties that will be acquired which are unknown to ValOre at present and which have been caused by previous or existing owners or operators of the properties.

Commodity Prices

The price of ValOre's securities, its financial results and exploration, development and mining activities may in the future be significantly adversely affected by declines in the price of base metals & minerals. These prices fluctuate widely and are affected by numerous factors beyond ValOre's control such as the sale or purchase of uranium by various dealers, government agencies and financial institutions, interest rates, exchange rates, inflation or deflation, currency exchange fluctuation, global and regional supply and demand; production and consumption patterns, speculative activities, increased production due to improved mining and production methods, government regulations relating to prices, taxes, royalties, land tenure, land use, importing and exporting of minerals, environmental protection and international political and economic trends, conditions and events. These prices fluctuate widely, and future serious price declines could cause continued development of ValOre's properties to be impracticable.

Further, reserve calculations and life-of-mine plans using significantly lower uranium prices could result in material write-downs of ValOre's investment in mining properties and increased amortization, reclamation and closure charges.

In addition to adversely affecting reserve estimates and its financial condition, declining commodity prices can impact operations by requiring a reassessment of the feasibility of a particular project. Such a reassessment may be the result of a management decision or may be required under financing arrangements related to a particular project. Even if the project is ultimately determined to be economically viable, the need to conduct such a reassessment may cause substantial delays or may interrupt operations until the reassessment can be completed.

Price Volatility

In recent years, the securities markets in Canada and elsewhere have experienced a high level of price and volume volatility, and the market prices of securities of many public companies have experienced significant fluctuations in price which have not necessarily been related to the operating performance, underlying asset values or prospects of such companies. Any quoted market for ValOre's securities will be subject to such market uncertainties and the value of such securities may be affected accordingly.

Key Executives

ValOre is dependent on the services of key executives and a small number of highly skilled and experienced consultants and personnel, whose contributions to the operations of ValOre are likely to be of importance. Locating mineral deposits depends on a number of factors, not the least of which is the technical skill of the exploration personnel involved. Due to the relatively small size of ValOre, the loss of these persons or ValOre's inability to attract and retain additional highly skilled employees or consultants may adversely affect its business and future operations. ValOre does not currently carry any key-man life insurance on any of its executives. The directors and officers of ValOre only devote part of their time to the affairs of ValOre.

Potential Conflicts of Interest

Certain directors and officers of ValOre are, and may continue to be, involved in the mining and mineral exploration industry through their direct and indirect participation in corporations, partnerships or joint ventures which are potential competitors of ValOre. Situations may arise in connection with potential acquisitions in investments where the other interests of these directors and officers may conflict with the interests of ValOre. Directors and officers of ValOre with conflicts of interest are subject to and do follow the procedures set out in applicable corporate and securities legislation, regulations, rules and policies.

Dividends

ValOre has no earnings or dividend record and is unlikely to pay any dividends in the foreseeable future as it intends to employ available funds for mineral exploration and development. Any future determination to pay dividends will be at the discretion of the Board of Directors of ValOre and will depend on ValOre's financial condition, results of operations, capital requirements and such other factors as the Board of Directors of ValOre deem relevant.

Nature of the Securities

The purchase of ValOre's securities involves a high degree of risk and should be undertaken only by investors whose financial resources are sufficient to enable them to assume such risks. ValOre's securities should not be purchased by persons who cannot afford the possibility of the loss of their entire investment. Furthermore, an investment in ValOre's securities should not constitute a major portion of an investor's portfolio.

OFF BALANCE SHEET ARRANGEMENTS

ValOre does not utilize off balance sheet arrangements.

TRANSACTIONS WITH RELATED PARTIES

Key management compensation

Key management consists of the Company's directors and officers. In addition to management and consulting fees paid to these individuals, or companies controlled by these individuals, the Company provides non-cash benefits. The balance payable to key management at September 30, 2018 was \$176,700 (September 30, 2017 - \$25,500) and such payables are unsecured, non-interest bearing and are expected to be repaid under normal trade terms. CRITICAL ACCOUNTING ESTIMATES

ValOre's accounting policies are presented in Note 2 of the September 30, 2018 audited annual financial statements. The preparation of financial statements in accordance with IFRS requires management to select accounting policies and make estimates. Such estimates may have a significant impact on the financial statements. Actual amounts could differ materially from the estimates used and, accordingly, affect the results of the operations. These include:

- the carrying values of exploration and evaluation assets;
- the useful lives for depreciation of equipment; and
- the valuation of stock-based compensation expense.

Exploration and evaluation assets

Resource exploration and development costs, including option payments, are capitalized on an individual area of interest basis until the properties are brought into production, at which time they will be amortized on a unit-of-production basis, or until the properties are abandoned, sold or management determines that the mineral property is not economically viable, at which time the unrecoverable deferred costs are expensed to operations. Option payments arising on the acquisition of mineral property interests exercisable at the discretion of ValOre are recognized as paid or payable.

Exploration and evaluation costs include cash consideration and the estimated fair market value of common shares or warrants on the date of issue as provided under the agreed terms of acquisition for the mineral property interest.

Capitalized exploration and evaluation costs are those directly attributable costs related to the search for, and evaluation of, mineral resources, that are incurred after ValOre has obtained the legal rights to explore a specific area and before the technical feasibility and commercial viability of a mineral reserve are

demonstrable. Any costs incurred prior to obtaining the right to explore a mineral property are expensed as incurred as project evaluation expenses in the statement of operations and comprehensive loss.

Management reviews the carrying value of capitalized exploration and evaluation costs each reporting period for indications of impairment. Exploration and evaluation assets are tested for impairment whenever events or changes in circumstances indicate that their carrying amount may not be recoverable. Where information is available, and conditions suggest impairment, the fair value of the mineral property is determined using net cash flows for the mineral property taking into account proven and probable reserves and resources, estimated future prices and operating, capital and reclamation costs. In the case of undeveloped projects, there may be only inferred or indicated resources to form a basis for the impairment review. In such cases, the impairment review is based on the exploration and evaluation results to-date and a status report regarding ValOre's intentions for development of the mineral property.

Recovery of the resulting carrying value of exploration and evaluation costs depends on the successful development or sale of the undeveloped project. If a project does not prove viable, all irrecoverable costs associated with the project are expensed to operations.

Once an economically viable reserve has been determined for a property and the decision to proceed with development has been approved, acquisition, exploration and evaluation assets attributable to that area are first tested for impairment and then reclassified to construction in progress within property and equipment.

The amount presented for exploration and evaluation assets represents costs incurred, less impairment costs, if any, to date and does not necessarily reflect present or future values.

Stock-based compensation expense

The grant date fair value of share-based payment awards granted to employees is recognized as an employee expense, with a corresponding increase in equity, over the period that the employees unconditionally become entitled to the awards. The amount recognized as an expense is adjusted to reflect the number of awards for which the related service and non-market vesting conditions are expected to be met, such that the amount ultimately recognized as an expense is based on the number of awards that do meet the related service and non-market performance conditions at the vesting date.

FINANCIAL INSTRUMENTS AND OTHER INSTRUMENTS

Categories of financial assets and liabilities

The fair value of the Company's cash and cash equivalents, other receivables, GST recoverable, and accounts payable and accrued liabilities approximate carrying value which is the amount recorded on the statement of financial position due to their short-term nature. The Company's marketable securities, under the fair value hierarchy, are based on level one inputs.

Credit risk

Credit risk is the risk of loss associated with a counterparty's inability to fulfill its payment obligations. The Company's credit risk is primarily attributable to cash and cash equivalents, other receivables, marketable securities and GST recoverable. Management believes that the credit risk concentration with respect to financial instruments included in cash and cash equivalents, marketable securities, other receivables and GST recoverable is remote as they relate to deposits and interest receivable from major financial institutions, related party balances, marketable securities held with a major brokerage firm and GST recoverable from the Government of Canada, and other balances which have been subsequently collected. The maximum credit risk as at September 30, 2018 was \$374,330 (September 30, 2017 - \$1,567,700).

Liquidity risk

ValOre's approach to managing liquidity risk is to ensure that it will have sufficient liquidity to meet liabilities when due. As at September 30, 2018, ValOre had a cash and cash equivalents balance of \$145,557 (September 30, 2017 - \$1,097,072) to settle accounts payable and accrued liabilities of \$514,805 (September 30, 2017 - \$231,374). All of ValOre's financial liabilities have contractual maturities of less than 30 days and are subject to normal trade terms. Management believes that ValOre has sufficient funds to meet its obligations as they become due. Management believes that ValOre has sufficient funds to meet its obligations as they become due as a successful rights offering was completed in January 2019.

Market risk

Market risk is the risk of loss that may arise from changes in market factors such as interest rates, foreign exchange rates, and commodity and equity prices.

(a) Interest rate risk

ValOre has cash balances and no interest-bearing debt. ValOre's current policy is to invest excess cash in investment-grade short-term deposit certificates issued by its banking institutions. ValOre periodically monitors the investments it makes and is satisfied with the credit ratings of its banks. As of September 30, 2018, ValOre had \$Nil (September 30, 2017 - \$1,003,945) in term deposits.

(b) Foreign currency risk

ValOre operates predominately in Canada and is not exposed to any significant foreign currency risk.

(c) Price risk

The Company is exposed to price risk with respect to commodity and equity prices. Equity price risk is defined as the potential adverse impact on the Company's earnings due to movements in individual equity prices or general movements in the level of the stock market. Commodity price risk is defined as the potential adverse impact on earnings and economic value due to commodity price movements and volatilities. The Company closely monitors commodity prices of resources, individual equity movements, and the stock market to determine the appropriate course of action to be taken by the Company. The Company maintains certain investments in marketable securities which are measured at fair value, being the closing price of each equity investment at the balance sheet date. We are exposed to changes in share prices which would result in gains and losses being recognized in total comprehensive loss. A 10% fluctuation in the price of the Company's marketable securities would increase/decrease comprehensive loss by \$14,811 as at September 30, 2018 (September 30, 2017 - \$32,198).
